Deposits can be made in person by cash, by cheque (payable to The Unthank Arms) or by credit card over the phone.

If you are unable to obtain all guests choices within 10 days, you must return the deposit to secure your booking.

If you would like to choose the two course lunch option the whole party will need to choose the same options, ie starters and mains OR mains and desserts. We're not able to combine two and three course menus within the same party.

To help remind your guests of their choice of meal we will provide name cards showing choices, which will be given to you on arrival.
